Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

General

I want to emphasise the need for at least one outdoor learning centre to be fully Gaelic medium. This will cater for pupils currently in GME, a growing sector, but there is also the possibility of creating a programme for any pupil to engage with the language and the outdoor environment as learners.
