Proposed Schools (Residential Outdoor Education) (Scotland) Bill

Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

If schools have to cover the cost of this, my concern would be that they will look for options that are the most cost effective and perhaps make decisions based on price rather than the quality. There is a huge difference in learning outcomes of a residential course that takes place at different providers. Some providers will provide a course packed with outdoor based adventures, but with little transfer of learning, or inclusion of learning objectives. At a high quality ,specialist outdoor education centre with highly qualified and experienced staff that can facilitate the learning through the outdoor environment, the benefits will be far greater. So an awareness of this needs to be clearly shared with all educational establishments, and appropriate funding available or ring fenced to ensure the best possible opportunities are given to all pupils.
