

Proposed Schools (Residential Outdoor Education) (Scotland) Bill

Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

The Independent schools model has changed in recent years with parents opting to send children to private education due to additional learning needs and more tailored support. These children may not have the affluence or affordability for all extra curricular activities so therefore some support may be needed to not leave these children behind.
