# Proposed Schools (Residential Outdoor Education) (Scotland) Bill

#### Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

The main barrier seems to revolve around funding, without which, many young people are unable to experience the natural environment. Without access to green spaces, these young people are missing out on opportunities afforded others from more affluent backgrounds. If legislation provides money and the "right" to access this, regardless of social status, then it supports social mobility too.
