

Proposed Schools (Residential Outdoor Education) (Scotland) Bill

Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

Equalities

The right for young people to access residential outdoor education should be universal and enshrined in law, regardless -in particular- of parent's religion. It should also be thought of as a civic duty in a democracy. Provisions, however, should be in place so that this is done in an inclusive way and in a way that is sensitive to the particular needs of every participant (beliefs, customs, sexual orientation, etc).

Q10. How might equity of provision for all be ensured, regardless of socio-economic status? Please give reasons for your response.

Those that qualify should be entitled to receive full funding by the state (the Scottish Government, in this case).
