# Proposed Schools (Residential Outdoor Education) (Scotland) Bill

#### Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

#### Please explain the reasons for your response.

I agree with the principles behind the bill; young people should have a right to access this type of experience as a minimum. Due to cutbacks in LA provision huge numbers of young people are missing out on formal outdoor education. Only the lucky few - or those attending private schools / paid activities - can expect to access this.

Q2. Do you think legislation is required, or are there other ways in which the proposed Bill's aims could be achieved more effectively? Please explain the reasons for your response.

Yes, legislation is required. Whilst it may appear desirable to use HMIe inspections, QA frameworks and CfE guidance to try and force adoption, my 20 years' teaching experience has left me feeling doubtful about this approach: I can think of numerous examples where loopholes, obfuscation and outright lying has been used to get around similar guidelines such as whole-school Digital Skills provision, Literacy & Numeracy, PE entitlements, Languages 1+2 expectations, etc. Laying down a bill in law would give parents and other parties a clear standard to hold education providers to.

I would prefer this bill to ensure all young people in Scotland receive an entitlement. My (limited) experience of private schools however tends to suggest they go far above this already, so less important but I think the law should apply to all pupils to ensure equity regardless of setting.

There would however have to be some form of uplift to the block grant to allow this to happen.

Many local authorities will face increased costs, having scaled down their staffing and facilities in Outdoor Learning. It could perhaps be considered to have a grant-based process that LAs could apply to in order to meet initial capital costs of reconstituting buildings, equipment and training.

As much as possible, parents/carers should not be expected to contribute to ensure equity of provision.

HMIe would be a good vehicle for analysing the quality of provision that schools / LAs are providing, but commercial centres should also perhaps be encouraged to sign up to a quality framework that could become mandatory if they wish to provide residential expriences that count towards the statutory requirements.

It would also be important to allow individual schools & LAs to develop independent programmes that meet the statutory requirement; nothing should stop a school from training their own staff and hiring accomodation to self-deliver a programme, rather than relying on a commercial programme. This can increase the value and depth of pupil staff relationships in a school.

This is a good range when pupils can start to take on more responsibility, leadership and challenge. It can also benefit those with low self-esteem or mental-health issues that often become apparent during early teenage years. Some consideration should also be given to upper primary (P6-7); from personal experience I benefited from an OE programme at this age; it was challenging to spend so long away from home, but did build my confidence.

I would hope it would increase the provision of outdoor programmes to those with physical disabilities who can often be overlooked when planning active events.

Any good outdoor educational programme should enhance the awareness of environmental impacts in young people, so I would hope any impact of this bill would ultimately be positive. Some consideration should be given however to the current & future residential estates; many of the facilities are in ageing, poor energy efficient buildings and can be difficult to reach on existing public transport.
