

# Proposed Schools (Residential Outdoor Education) (Scotland) Bill

## Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

I am a parent, a grandparent and a CEO with 30 years experience in early learning and childcare, children's and youth services. I attended a residential outdoor experience as a teenager brought up in an area of multiple disadvantage. The impact of attending this trip has remained with me my entire life. Being away from home with a group, immersed in sailing, canoeing, abseiling, and cooking outdoors were new experiences. Whilst I wasn't fully aware of the impact at the time, these experiences have shaped my approach to life and have influenced my career decisions. I left school with no qualifications returning to academia later in life to MSc level. I cannot convey strongly enough how each child should have this opportunity to connect with nature, build resilience and try things they may never have the chance to do. I have seen first hand the impact spending time outdoors has on children's mental and physical health. I currently head up a growing chain of fully outdoor nurseries in Scotland using our profit for purpose. Spending quality time outdoors is the most rewarding place for children, young people and grown ups.

Any statutory provision requires a sustainable plan to ensure delivery. The actual costs should be well defined in advance and transparent. What should be avoided is any situation where local authority provision is seen as a better option because the costs are absorbed within the council. We have seen this with the expansion of ELC where the legislation states 'provider neutral' but doesn't state 'employer neutral'. This means that the local authorities can pay staff more than the PVI sector, creating a very unfair playing field, impact on quality and significant staff shortages.
