# Proposed Schools (Residential Outdoor Education) (Scotland) Bill

### Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

#### Please explain the reasons for your response.

As a result of the Covid pandemic, many young people not had the opportunity to go on what I would argue is the "right of passage" that is their P7 trip. Even prior to the pandemic, the number of schools able to offer residential outdoor education trips was falling due to the closure of outdoor centres and other factors. This is a missed opportunity for young to build resilience, develop peer-relationships and gain an appreciation for our beautiful country. I therefore believe that it is critical that young people are afforded this opportunity during secondary school.

As a teacher, the opportunity to see young people act like their "true selves" as soon as they are taken into an outdoor environment away from the social pressures of the classroom is incredibly rewarding. I also believe if all children were afforded this opportunity during their time at secondary school, the mental health benefits of time away from the classroom surrounded by nature would far outweigh the class time lost in terms of improving attainment. I could write for hours about the benefits of outdoor education on physical health, mental health, social and emotional development, sustainability... the list could go on! I wholeheartedly believe that this bill should become law, so that more young people and their teachers have the opportunity to experience the benefits of time out of the classroom in our great, Scottish, rainy, midge-ridden outdoors!

Q2. Do you think legislation is required, or are there other ways in which the proposed Bill's aims could be achieved more effectively? Please explain the reasons for your response.

I would argue that without mandating the opportunity for young people to go on a residential outdoor trip at secondary school, most young people in Scotland will never be offered this opportunity. Schools and councils are tight-pressed in terms of both time and money, so often outdoor education falls to the bottom of the priority list.

Making residential outdoor education "encouraged" rather than "compulsory" could also lead to an even greater poverty related "achievement gap" as well as attainment gap. This is because even where trips are fully funded, children from middle-class homes are more likely to be encouraged to sign up for these trips; and middle-class parents are more likely to put pressure on schools to run such trips.

I support the obligation falling on councils and schools. Schools could perhaps appoint PT Outdoor Education positions which would hopefully increase the number of children also involved in non-residential outdoor education activities as part of the school curriculum.

I would argue that costs should be covered in part by parents and carers, but with significant government subsidy. Perhaps a cost of £100 per pupil to parents and carers and £100 covered by government grants.

I do however think FSM entitlement is not a sufficient measure of which families are struggling, and schools should be able to apply for further fully-funded places on behalf of other families who are unable to pay.

I think it is important to remember that residential trips do not need to be "all singing, all dancing!" It is also arguably more inclusive to include activities such as paining in nature, building a campfire, and simply going walks in the countryside; over high-cost activities such as rock climbing and gorge walking. Schools could also be encouraged to include at least one day of conservation work as part of the trip to keep activities costs down. In addition, despite the initial costs, money could be saved by paying for school staff to gain their Lowland Leader Award, cycle leader qualifications etc. Likewise despite the initial cost of tents, some or all of the trip could involve camping which again brings down costs.
