

Proposed Schools (Residential Outdoor Education) (Scotland) Bill

Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

If children receive a high quality experience in the outdoors, they are likely to return to outdoor activities later in life. This is the result of the Sports England study into motivations to participation in outdoor activities. So, a small investment in young people will ultimately help more of them into active healthy lifestyles which will then reduce the burden on the NHS. Obesity is a very expensive problem.
