Proposed Schools (Residential Outdoor Education) (Scotland) Bill

Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

For too long. Children have been in a sterile education environment that is not suited for everyone. Increased focus on the process of teaching, and transfer of authoriy away from teachers towards parents/pupils has caused a huge discipline problem that remains unsolved. Studying is not for everyone, outdoor education is vital for large numbers if children yet is neglected or relegated to a DofE leader at the school (I do not agree with DofE being a scheduled subject) as the only means of "handling" non-studious pupils

Funding

Schools in disadvantaged areas already have money to spend on these types of activities. There needs to be a) investment in facilities and b) additional funds for schools (pro-rata) to handle the role of organising and possibly paying the LA / commercial outdoor centre.

Most LA have removed outdoors centres, and would depend on non-LA centres to deliver the residential activity until such time as the LA could invest in building there own. Money for investing in LA should come from the existing LA budget backed up by ring fenced funds from central gov. A tax rise of 1p could easily fund this many times over

The Scotgov has fixed budgets with limited ways of raising new money. Investment in centres, land, equipment, staff, catering, insurances, teachers comes at a cost.

Offsetting this cost will be a refuction in disruptive behaviour, reduction in mental health issues, reduction in use of nhs resources, improvements in education system by behavioural improvements

I teach children from P5 in the outdoors. They are the perfect age to start with, strong enough to take part in activities, and open enough to embrace the outdoor environment. 12 is ok, but too late for many inner city children

We live in an area with many immigrants, none of whom have the chance to visit the outdoors. There is a lot of economic deprivation in our city, again these children are not connected with the environment outside their local area. I volunteer, taking groups of Muslim hillwalkers into the mountains to share and improve understanding of our histroy and landscape.

The outdoors is the ultimate level playing field. Each activity demands a slightly different set of muscles, concentration, endurance, fear and balance. There is something for everyone

Q10. How might equity of provision for all be ensured, regardless of socio-economic status? Please give reasons for your response.

Today, there are too few centres offering provision. The numbers would need highly increased and each facility would need infrastructure improvements. Eg removal of some existing huts and rebuilding new. Covid removed huge numbers out of the outdoors employment sector, no furlough meant no money. I had no income for 18months and watched many colleagues give up and leave the industry. There is barely an outdoor industry left in Scotland other than a few charities (who are on their knees financially) and two high profile centres in Aonach Mor and Wolftrax.

This initiative should be seen as a massive reboot of the education and outdoor industry for all children. It must be available to all children regardless of how poor they are, in the same way as the outdoors is available to all. It resonates.

The proposal would stem the flow of staff leaving the outdoor activities industry. For minimum wage, I am legally responsible for everyone in my care - on a mountain, in a forest, on a river even just walking beside a road.

I need personal insurance, public liability indemnity, technic equipment, a car, huge amounts of training beyond degree level, first aid recertification, a website and all that goes with that.

Working in the outdoors is a great way of transforming a large pot of money into a small pot of money and if I hadn't a career beforehand to save up - it wouldn't be something I could afford to continue with. Raise the bar generally. More centres, more staff, more money for staff, more respect for the outdoors in governement generally.

Thats your foundation for improvement.
