

Proposed Schools (Residential Outdoor Education) (Scotland) Bill

Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

Education through residential experiences, alongside outdoor learning fully integrated into the school curriculum, have strong empirical evidence to illustrate its wide benefits to learners in primary and secondary education (see <http://learningaway-org-uk.stackstaging.com/wp-content/uploads/LA-Final-Report-May-2015-1-1.pdf>). The benefits to students in developing their personal and social development, appreciation of the natural world and mental and physical health should ensure that outdoor residential experiences are valued and funded by local and national government. In a world of increasing habitat loss and climate change, outdoor residential settings are an opportunity for learners to engage in critical questions on local and global issues. The benefits of residential experiences also stretch into supporting learners to care for and protect the environment. This stretches into supporting them to care for and be active in their local communities.

Q2. Do you think legislation is required, or are there other ways in which the proposed Bill's aims could be achieved more effectively? Please explain the reasons for your response.

Legislation is required to ensure that learners in all local authorities experience the opportunity to participate in residential experiences. The number of centre closures and funding cuts would suggest that, left to chance, residential opportunities will decrease in Scotland.

A progressive approach to residential experiences is essential to support learners needs (shorter more locally based overnights, that then extends into longer residential experiences). So yes, whilst the legislation may focus on 12-16, residential should be encouraged at earlier stages.
