

Proposed Schools (Residential Outdoor Education) (Scotland) Bill

Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

It would be sensible to look at the framework set out by LOtC - Learning Outside the Classroom for whom I have been a senior inspector in the Adventure sector for the past ten years. The quality inspection needs to be of the OE providers not the school, even if the school is the provider.
