# Proposed Schools (Residential Outdoor Education) (Scotland) Bill

## Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

#### Please explain the reasons for your response.

Outdoor education and residential experience have need conflated. Both are valuable, but they are not the same. By linking them this is less likely to succeed due to cost. I am also of the view that access to adventurous activities without a residential makes it far more accessible long term, and is much more cost effective.

I think legislation is helpful to ensure hard pressed resources are allocated. It would also be useful to define what is meant by outdoor education. Previous attempts have accepted outdoor learning as anything that happens outside the classroom. I think the intention of this proposal is for an experience more complex than that.

Not all schools currently access this kind of experience. As they all have this opportunity costs will obviously increase. More importantly, there is not currently capacity to provide this. If this becomes compulsory, the supply demand issue will drive up costs. As commercial providers fill the gap this may force out of the market the remaining LA providers (very few left). I have mixed vows as to whether or not that would be a good thing.

This bill has not defined outdoor education and as I have said earlier previous attempts have diluted the concept as schools have discovered the difficulties sourounding quality provision of adventurous outdoor activities, particularly those with learning outcomes which are not about acquiring skill in relation to the activities.

Accessing from their community over time and progressively creates a belief that the environment and adventurous experiences are theirs for life and not just when being led by an old bearded man (that's me) from a old highland house far away from home. Access to these experiences are life changing, but much more so when accessed over a life time.
