Proposed Schools (Residential Outdoor Education) (Scotland) Bill

Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

I know first hand how important it is to improve the reach of outdoor education to all young people in Scotland. I am privileged to see the benefits of outdoor education on the young people I work with every day.

Q2. Do you think legislation is required, or are there other ways in which the proposed Bill's aims could be achieved more effectively? Please explain the reasons for your response.

The Scottish Government has been brilliant at promoting the benefits of outdoor education, including a whole section on learning in the outdoors in the Curriculum for Excellence. However, it is very unfortunate that this does not filter down to the individual local authorities who are making the budgeting decisions which will ultimately determine whether or not young people are able to access an adventurous outdoor education residential trip. This has played out in recent years with the closure of Kilbowie Outdoor Centre and inexplicably, Glasgow City Council (an SNP council) voting to close Blairvadach Outdoor Education Centre. Thankfully the latter decision was reversed after some backlash from the citizens of Glasgow and the media. It is clear, therefor that legislation is indeed required, otherwise local authorities (who can seldom see further ahead than the next 12 months budgeting period) will continue to close centres as they have done for several decades (see "Residential Outdoor Education in Scotland: change over time and the impacts of socio-economic deprivation on access" by R. Davies (2018)).

My opinion is that it is local authority funded schools which really require this provision to be legislated as per my previous answer detailing the problem with local authorities closing outdoor education centres. Compelling local authorities to place value in outdoor education would protect these centres and the vast amount of expertise of their staff from being lost.

Funding

Many parents are more than happy (and able) to pay for their child's outdoor education residential. Many parents are unable to, the majority of these would receive funding via means testing. In my experience, school staff are excellent at identifying the children who fall through the cracks (i.e. dont meet means testing requirements for funding but are unable to find the money for such a trip). Schools, in my experience, are very good at finding funding from elsewhere for those children and/or fundraising for the trip (I have heard of parents doing sponsored runs to raise money for an outdoor ed residential for example, schools running bake sales etc).

Financial Implications

Local authorities will need to find (i.e. be given) additional funding for children to access outdoor education residentials and also to invest in local authority owned outdoor education centres. Without getting too political, there are plenty of areas where money is (in my opinion) wasted, which would be better spent on providing our young people with the opportunity to take part in adventurous outdoor education residentials. Developing a connection with the natural environment in an inevitable part of doing adventurous activities outdoors - this has been shown time and again to improve people's willingness to behave in pro-environmental ways (see "The NR6: a new brief measure of nature relatedness" by Nisbet & Zelenski (2013)). So finding the funding for providing outdoor education residentials could be argued as vital to help our young people, the next generation, to find the motivation and ability to tackle the climate crisis. Surely THAT is worth any cost?

residential is used to enhance learning and personal & social development, a clear quality framework would be helpful.

This age range would target S1-4 in the Scottish school system. In my experience, 10-11 year olds benefit greatly from an outdoor education residential in P7 as it improves their confidence, independence and team work skills prior to their transition in to secondary school. I think widening the age range to 10-16 year olds would be helpful.

In my experience, girls from certain religious backgrounds have not been allowed (by their families) to go on residential trips. Thankfully this issue seems to be reducing in recent years. Regardless, perhaps being able to offer female only residentials would help, particularly if parents understand that these trips are legislated for because they are so important.

Means testing of income (i.e. free school meals funding) could be used.

Sustainability

Yes, as detailed in my previous answer, any time spent engaging in outdoor adventures will inevitably lead young people to develop a deeper connection with the natural environment. This has been shown time and again to increase participation in pro-environmental behaviour as individuals suddenly have more of a reason to want to protect it.
