

Proposed Schools (Residential Outdoor Education) (Scotland) Bill

Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

50% of children are adventurous, again a simplification but essentially true. It is in fact a spectrum from the very timid at one end to the extremely adventurous at the other. Often the individuals toward the adventurous end of the spectrum find it difficult to find an outlet in an increasingly ordered society. Their need for adventure is deeply rooted in the human psyche and will find an outlet, often in socially damaging ways eg drugs, crime violence. At an outdoor centre they find an outlet through challenge and a channel for this pent up reservoir of energy. Working in small groups, under the expert guidance of the established and experienced instructors, using tools of challenge through choice the individuals find ways to control and direct this emotional and physical energy regardless of their position on the adventure spectrum. Again when they return to their home environment they have been equipped with tools and directions in which to steer this with a very positive cost benefit to the local community.
