Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

Not all children are academic and poor performance at school can negatively impact on confidence and self-esteem. Outdoor Learning / AT can help children of all levels connect with the natural work, appreciate the benefits of physical exercise and challenges as well as gaining confidence and self-belief through achievements.

There are also opportunities to tie in with DofE and John Muir Award schemes.
