Proposed Schools (Residential Outdoor Education) (Scotland) Bill

Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

My local school can only afford to send primary children on a 2 night residential and even then many parents can't afford that cost. There is no funded provision within secondary school. We have been fortunate that we have an active Scout group locally and have been able to afford their discounted rates. My daughter has been fortunate enough to be part of a team who trained and went on expedition with The Polar Academy. This has been totally life changing for all of the young people first hand and was fully funded by the charity - I have seen first hand that it works.

Opportunities will keep going to the same young people where families have the means and the interest in facilitating these activities. I've taken part in the Field Studies Family Holidays programme which offers heavily discounted activity breaks for families. They are fantastic but it was clear that most of the families booking that programme could have afforded to pay a lot more. Lack of money isn't the only barrier, if this isn't facilitated through the school system then it won't be facilitated at home for many young people.
