# Proposed Schools (Residential Outdoor Education) (Scotland) Bill

#### Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

#### Please explain the reasons for your response.

We support the principle and fully support outdoor education provision, however there are limitied options for this to take place within Highlands on a residential basis without long travelling times/distances, and so we would like to see the scope of this bill widened to include outreach delivered. Highlands has no shortage of outdoor venues locally, we do have a shortage of qualified professionals employed to deliver to schools.

Q2. Do you think legislation is required, or are there other ways in which the proposed Bill's aims could be achieved more effectively? Please explain the reasons for your response.

From a Highland perspective, we have the natural resources to be able to have a year round programme delivered locally for young people. We lack the funding and skills shortage to achieve this currently.

We have seen the positive impact of using the outdoors in improving well-being and closing the attainment gap for our young people.

Legistalation would be required to make these activities consistently available, however the bill as it stands needing to be residential, would require much larger resources into infrastructure to allow this.
