Proposed Schools (Residential Outdoor Education) (Scotland) Bill

Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

Each local authority has slightly different priorities and therefore ways of allocating and managing budgets. Unless the residential outdoor education is funded directly by the Scottish Government, there is a risk that not all pupils would actually experience the learning in similar way.
