Proposed Schools (Residential Outdoor Education) (Scotland) Bill

Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

Q1. Which of the following best expresses your view of the proposed Bill? (Please note that this question is compulsory.)

Please explain the reasons for your response.

I see the benefits of outdoor learning all the time through volunteering with Scouts. However, I am fortunate to live in a rural area, where the Scouts enjoy considerable support from local landowners which allows us to run regular camps at low cost. Not all children are in a position to join organisations such as Scouts (although Scouts would never turn a young person away because of their financial circumstances), and not all Scout groups are able to access sites for camping.

Scout land is a largely rural country, and engagement with the countryside is important to Scottish identity. The response to COVID showed that Scots need to be outdoors, but that in some cases, people do not have the skills to allow them to undertake outdoor activities such as camping and wild swimming in a safe and responsible way. Including outdoor education within the schools programme would help to ensure that young people have the skills and knowledge to access the outdoors safely. In addition, residential outdoor activities build confidence and team working, and can particularly benefit pupils who find the classroom environment and formal learning difficult.

Children from less affluent inner city areas stand to gain most from increased outdoor education provision, as they are less likely to be able to create informal adventures on their doorsteps and their families are less likely to own cars to transport them to rural areas. However, all children benefit from outdoor education, and stretching themselves in unfamiliar environments.

There is also a growing disconnect between people and the natural environment, which is shown by reducing knowledge of wild plants and animals. Outdoor education can help address this. Improving understanding on the richness and diversity of the natural world is vital if we are to create a sustainable Scotland.

Q2. Do you think legislation is required, or are there other ways in which the proposed Bill's aims could be achieved more effectively? Please explain the reasons for your response.

It would help if Scotland was independent and voted the Tories out. It is somewhat ironic that this bill is being proposed by a Tory MSP when it has been Tory austerity that has led to cuts in outdoor education across the UK.
