

Proposed Schools (Residential Outdoor Education) (Scotland) Bill

Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

Please explain the reasons for your response.

As a school pupil in 1965 I benefited from a week at Edinburgh's Benmore Outdoor Centre, and as a student in 1972 a week at Loch Eil Outdoor Centre. These were great experiences and (along with scout camps) they gave me valuable personal development experience and a love of the outdoors that has stayed with me my whole life. In my working life in Aberdeen as a youth and community worker I used the various Grampian Outdoor Centres to take young people away for short residential experiences which had the benefits described by the MSP in her video. I firmly believe outdoor education and especially residential OE should be available to all young people

Yes because as I understand it much of the previous outdoor residential provision has been lost through Council cutbacks. Also to be a universal provision local authorities must be required to provide it.

Funding

Clearly there would be a cost implication since there is no room in budgets to take on new responsibilities. Increasing tax at the higher ends of income tax and council tax would take a contribution from those who can afford it. There should be an examination of the cost effectiveness of past provision. Is it better to have fully staffed and equipped centres to which schools book in (eg Edinburgh's Benmore Outdoor Centre), or is it better to have unstaffed centres which are staffed and equipped from a central council resource (Grampian Region model)?
