## Proposed Schools (Residential Outdoor Education) (Scotland) Bill

#### Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

I have first hand evidence and experience of how a School Residential Outdoor Education experience can enhance an individual's confidence and awareness and also show how to work as part of a team. I have witnessed many young people leave a residential week with increased confidence and self esteem.

I believe legislation is required. I have watched over the last 30 years the erosion of provision of Outdoor Education for young people and would like to see a reversal of this. It is not something that will be achieved by 'asking' education authorities to do something about it. Finance will need to be ring-fenced and applied in a fair and equitable way.

However this could be looked at in a more complex way and it may be that there are hidden savings due to the outcome of the Bill. e.g. better behaviour in schools, better attendance in schools, improved work ethic, job prospects, mental and physical health improvements - all leading to a reduction in the need for costly additional services.

personal development. There is more physical robustness and self awareness - often lacking in the younger ages - which equips them better for a residential experience. There is a case too for final year primary pupils having a residential as 'preparation' for leaving and/or simply a memorable and influential end to the first stage of their education.

## **Equalities**

While this act may not suit everyone there has to be acknowledgment of this and allowances made. It could be that it will require some very individualised or bespoke opportunities that form part of the Bill. These would be easy enough to identify and integrate and fundamentally provide choice.

As previously indicated this could be done by full Government funding. No -one should be excluded due to financial reasons. There are likely many barriers facing some people e.g. lack of good clothing for a residential week. Obviously these kinds of things will need sensitive handling but resources could be developed to help with this kind of thing.
