

Proposed Schools (Residential Outdoor Education) (Scotland) Bill

Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

Q1. Which of the following best expresses your view of the proposed Bill? (Please note that this question is compulsory.)

I firmly believe that the opportunity for outdoor residential experiences for young people requires safeguarding through statutory instruments. Without such safeguarding young people will continue to be deprived of potentially transformative and life changing experiences through the continued erosion of residential outdoor education provision - illustrated in the consultation document.

Q2. Do you think legislation is required, or are there other ways in which the proposed Bill's aims could be achieved more effectively? Please explain the reasons for your response.

Outdoor learning provision is already a requirement of GTCS professional development and the HGIOS framework. However, in order to secure sustainable residential outdoor education, which is high quality and value for money, the sector requires the confidence that only a statutory instrument can provide. The COVID-19 impact highlights just how vulnerable the sector is.

Q3. The proposed Bill will cover residential outdoor education provision for local authority and grant-aided schools only. Which of the following best expresses your view that independent schools or any other education establishments should not be covered by this obligation.

accommodation, facilities, equipment, qualified instructors/teachers - will help to ensure the stability and confidence to invest in and provide high quality residential outdoor education experiences.

Travel to/from residential outdoor education centres should be funded by local authorities. It seems reasonable that parents/carers cover the cost of normal everyday expenses, specifically food, with costs being covered by public funding where children meet criteria for financial support (e.g entitlement to free school meals)

This age range restricts opportunities to secondary school pupils. Scottish residential outdoor education has a strong association with P7 pupils transitioning to secondary school. It is imperative that primary school pupils are not neglected in this provision.
