# Proposed Schools (Residential Outdoor Education) (Scotland) Bill

## Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

Seeing the benefits which young people can gain from residential outdoor experiences. I am disappointed that in the consultation document on reference is made to sail training as a sea based outdoor education experience and that its focus is very much on the provision of land based services. Sail training has a proven record of providing meaningful learning experiences which benefit young people and this is well documented through academic study, eg Edinburgh University

The vast majority of young people are part of the public education system. In the private education sector there is at least one Scottish school which I am aware of in which outdoor education is very much part of the ethos of the school, but participation may well be funded through additional fees being met by the participants' family.

In a sail training situation, an understanding the marine environment and marine pollution is developed, along with an appreciation of the power of the elements and how they can be harnessed for benefit, while throughout the experience participants are constantly cooperating to achieve group goals as well as learning new skills.

In the post Covid pandemic period, there is a clear need to address the issues which have been highlighted over the last two years in relation to the mental health and well- being of young people.
