

Proposed Schools (Residential Outdoor Education) (Scotland) Bill

Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

Currently, it is our experience that residential outdoor education is more common for primary-school age children, particularly the P7 cohorts. I think progressive outdoor education programmes are important and that residential outdoor education is important throughout both primary and secondary education. Perhaps extending the age range to cover upper primary age (8-16) would make the legislation more achievable, with an encouragement to provide residential outdoor education in both primary and secondary education.
