# Proposed Schools (Residential Outdoor Education) (Scotland) Bill

### Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

For this to be delivered in a way that best suits the needs of the young people, rather than simply ticking a box, Schools themselves will need to be involved or have the responsibility to provide the outdoor education. The bill also needs to be clear what "residential" means. Would a DofE expedition with students camping over night count towards this? Does it need to be a solid week or a week in total? (There are merits to both).

Authorities already manage the safe delivery of outdoor education and residential trips). This the money needs to be ring fenced to ensure it goes directly to the costs of delivering the programmes not high level management.

There will be costs for these provisions. But there are so much flexibility in the term "residential" experience that local authorities and schools should be able to provide some form of experience whatever. A week of camping is a very different cost to a week in an outdoor centre.

A quality framework is important however the most important part of any quality assurance programme is knowledge by its creators. With residential experiences covering everything from walking to sailing, the quality framework is not simple, and I don't think should sit with HMIE. The MCA would be better placed to ensure offshore sailing experiences are suitably run, AALA or mountain training Scotland would be better placed than HMIE to quality assure many activities.

range was extended to include younger students this would aid that transition. The bill should also consider whether multiple opportunities need to be available. Primary to high school is an important stage, as is movement from BGE to certificate and high school to post 16 studies - UCAS applications for example.

I think used correctly and if schools and other organisations have the correct flexibility this law could have a very positive outcome for all young people, many of whom have been mentioned specifically above. But schools and youth workers will need to flexibility to provide opportunities when they deem they are best needed rather than "to LA have said all S1s are going next week to an outdoor centre" for example.

The "funding" is provided per pupil, and held against that pupil till spent. Schools, LAs etc aren't just given a pot of money to spend, instead there is "£500 allocated to each young person in Scotland aged 12-16" some socio economic groups may also be given additional funds a "top up/premium" for example as they may need a more specialist (thus potentially expensive) experience.
