#### Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The annual sum to fully fund provision is not excessive in terms of the overall schools' budget. Savings on other allocations across the block grant could provide the necessary funding, but if the health and wellbeing of young people recovering from the impact of Covid, is anything more than political rhetoric, then new money should be provided to meet the cost. It is important that providers are paid realistic sums which cover their costs and that they are not encouraged to offer provision below true cost price or the outcome will be that as providers fall by the wayside due to financial pressures, no new providers will come forward unless the real cost of provision can be met.

While there is a role for HMIs to provide quality assurance, a more significant and important role for them would be to provide an overview of best practice which they could disseminate across the country. It is also essential that providers produce comprehensive risk assessment, have appropriate and comprehensive insurance and that instructors are suitably qualified in the appropriate disciplines. This would apply to sail training where MCA or RYA qualifications are currently accepted.

From the experiences of individual whom have participated in sail training it is clear from their individual comments that the experience provided through residential outdoor education has enhanced their personal lives. This is a view which in echoed by their parents who have noted significant improvements in their child's attitudes, commitment and interactions with others from having experienced living and working as part of a group where cooperation within the group is essential

#### **General**

It is essential that the payments which will be made to providers reflect the true cost of service provision. If the mental health and wellbeing of our young people are to receive the attention which has been suggested is required to overcome the impact of Covid on our youth and establish positive practices for the future, the bill needs to move through to become law so that Residential Outdoor Education becomes a funded part of the secondary school education. In establishing a definition of Residential Outdoor Education, it is essential that sail training is included within that definition so that the very positive benefits which have been identified in academic studies of sail training can become available to our young people.
