# Proposed Schools (Residential Outdoor Education) (Scotland) Bill

### Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

I am a parent of teenagers in senior phase and have watched the change of so many young people from active, outdoorsy primary and early secondary children into inactive Netflix and social media addicted teenagers. The loss of an active lifestyle happens dramatically in this age group (maybe worsened by the pandemic) and this is a good proposal to try and counter this. Teaching importance of a healthy lifestyle has sadly little impact on behaviour. Experiences can be more effective.
