

Proposed Schools (Residential Outdoor Education) (Scotland) Bill

Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

It is imperative that all settings are managed or assessed regularly to ensure quality of education. I don't believe the schools should have an inspection specifically as the residential centres would be more responsible to ensuring the planned days are appropriate, challenging, safe, nurturing, responsive to children's learning as appropriate. HMIE could certainly ensure as part of school inspections that this was well organised and effective within a school's planning and implementation but the residential centres would really be the ones to be assessed in detail for quality opportunities offered to children.
