## Proposed Schools (Residential Outdoor Education) (Scotland) Bill

#### Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

Partially supportive

Please explain the reasons for your response. I think that while a good idea in principle there are implications such as: Funding - who is paying for those families that cannot afford it? Provision - is there enough provision for all schools? In certain areas this is restricted. Q1. Which of the following best expresses your view of the proposed Bill? (Please note that this question is compulsory.)

Additional needs - there is no suitable provisos for children with complex ASN in Scotland, instead pupils travel to Bendrigg (Cumbria) or Kielder; this has huge staffing implications due to the cost of staffing which increases the overall cost, cover in school, etc. If it's for all children perhaps this should be factored into account with suitable provisions being funded first.

Q2. Do you think legislation is required, or are there other ways in which the proposed Bill's aims could be achieved more effectively? Please explain the reasons for your response.

Legislation is not required. Most schools offer residentials - the only thing legislation will do is put pressure on funding at schools and local authorities. Staff are not obliged to go on residential service and receive no additional payment; making it legislation potentially leads to increased costs and a battle with Trade Unions as this will undoubtedly be raised.

Q3. The proposed Bill will cover residential outdoor education provision for local authority and grant-aided schools only. Which of the following best expresses your view that independent schools or any other education establishments should not be covered by this obligation.

Schools do not have budget for asic resources and could not possibly afford the costs associated with this, all the more so when paying for pupils and the high staffing levels associated with ASN.

Costs associated with residential are huge and if it becomes something that staff are made to do this has contractual obligations also. Costs for pupils is large, staffing needs to be paid for, transport costs are large.

It would also ensure that children with complex additional needs are catered for and provided with suitable facilities from the outset. The bill cannot be passed without full consideration of ALL children.

Partially supportive

16 is perhaps a little late due to the impact on exams, but dependent on whether pupils are academic or vocational in pathways this could support.
