

# Proposed Schools (Residential Outdoor Education) (Scotland) Bill

## Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

Most p7 classes in my area go on some form of outdoor experience. P7s are usually younger than 12 at the time of the trip so I feel the age could be lowered to allow for this to continue as part of the p7 curriculum.

Once they are in high school who would be responsible for ensuring a year group went on a week away? Which department would oversee that?

Some departments already do their own trips e.g the history or geography departments but not all pupils will take those subjects or be interested in a historical or geographical context. If done in p7 its more about the outdoor experience and building skills outwith any set subject heading its more interdisciplinary and about an outdoor adventure experience that the children otherwise might not have.

## Equalities

Children with severe and complex needs should also be considered. How is someone who needs a wheelchair going to access this provision?

Or someone who is autistic and needs structure and predictability and continuity. It might be exclusive of those individuals to make it a law that requires all people to access it. Some children with complex needs might not want to or be unable to take part their carers and school staff shouldn't then be considered to be in breach of a law.

It must be funded for those of low socioeconomic status so they are not excluded. Also think of the costs associated with having to buy outdoor clothes for a trip like this where the children will need waterproof clothes and shoes none of which are cheap
