

# Proposed Schools (Residential Outdoor Education) (Scotland) Bill

## Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

Having escorted Primary 7 pupils on outdoor residential trips in the past I think that this stage is the perfect time for them to go, preparing them for independence and allowing them a basis to develop skills they will need for their secondary education. 10-12 may be a better age range.

## General

My current experience being a teacher in NLC is that previous residential experience was more effective than the current model that has pupils go by bus everyday to experience the outdoors. Residential accommodation should be fit for purpose including any accommodation for accompanying staff. Indoor decor and facilities should be of a standard that pupils can enjoy and the facilities need to be maintained.
