Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

Please explain the reasons for your response.

As a child I went regularly every year on a school trip from primary school right through to secondary on residential trips. This was within school time. Now as a mother of three young children who are either denied this opportunity or it's limited to one p7 trip and then out of school trips in academy IF they even run is both sad and shocking, especially when you compare it to the rest of the UK where in England residential trips are still happening far more frequently. The benefits, rewards, developmental milestones, the mental and physical benefits of away trips for all children of all ages can not be understated. In a world post covid where the effects have been so detrimental on childrens mental and physical health, where confidence and self esteem has been shattered these trips are crucial in building a child up and giving them skills for life and encouraging them and showing them they can achieve anything. I am already deeply saddened as said that Scotland is currently so limited in what it offers children a massive disservice to deny them the opportunities trips like these poses. There was a reason we had so many centres and it worked before. Sadly the political nonsense, interfering in school systems and and over bearing Health and Safety policies ground these trips into ground to the detriment of generations of children.

I'm not sure, if it meant that schools and governments couldn't back down, change their mind or deny children trips then yes it needs legislation. If it can just be put into the schools curriculum without legislation then great though my worry is it could just as easily be removed again in the future. I don't really know enough politically for the reasons or difference between putting it through as legislation or getting it done without?

Yes it would also be great to say every parent pays for their own child and just those in need (benefits, low income etc) get paid by the authority BUT we are in a cost of living crisis and every family is squeezed and as normal those on low income receive help, those on high wages do fine and it's always those in the middle who actually get no help who are the worst off. I think if it could be spread between parents, public body's and fundraising then it would allow more people to attend.

Don't get me wrong if some money could be ring fenced or allocated yearly for trips that would be great to support these happening and cover some of the costs ie the running of the centres so the fees are less to attend that would be amazing, but we also can't expect government to pay for it all as the money just isn't there and there are also lots of other things schools are having to balance the books on and that money needs spending on educationally.

However if it was shared between government and parents with still help for low income and an element of fundraising throughout the year too hopefully costs can be met.

If the centres were staffed and ran by authorities then there is an element of keeping costs lower perhaps and then if in use by all schools all the times it makes them financially sound if parents cover accommodation and food and perhaps travel but the trip itself is then subsidised or costs kept low or the the trip/activities are free at point of use so long as accommodation and feed etc has been paid.

As much as I'd like to tick the box that says get the government to pay!!
