Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

General

As a teacher, now retired, I was involved in the provision of outdoor education and outdoor learning facilities, initially at a school serving an area of extreme multiple deprivation, and latterly at a Special Needs school providing mainly for young people on the Autism Spectrum. At both schools OE was on the

curriculum for all learners. That programme was enhanced by comprehensive Residential Experiences programmes at outdoor centres in Scotland and the North of England. In addition and where funds could be raised, trips to Europe and the US were provided. The ski programme for ASD children was particularly successful. They were introduced to skiing at Midlothian Snowsports during curricular OE. An extra-curricular group then met on Friday afternoons during term time at the same venue. Day trips to the indoor snow facility at SnoFactor took place once a term. A weekend trip to Lagganlia OE Centre was organised when snow was available. To complete the full range of ski experience, trips to European and US resorts took place. That one comprehensive programme helped the young people develop and mature. Self confidence and self esteem were enhanced. Skiing was included in their Duke of Edinburgh's Award courses. Parents saw their children participate in an extensive physical activity programme which seemed an impossibility given the children's diagnosis of Autism Spectrum Disorder. The ski programme also saw teaching and support staff access personal ski qualifications to participate and promote the programme.

Curricular OE introduced learners to canoe/kayak, hill and coast walking, dinghy sailing, and orienteering. Senior pupils participated in the Duke of Edinburgh's Award, involving practice and qualifying expeditions with overnight camps. All secondary and senior primary learners were expected to participate in at least one Residential experience per year at an OE centre in Scotland and the North of England. Initially these were taster courses with learners experiencing a variety of activities, latterly, with the young people having already gained experience of a number of outdoor pursuits, they could chose to concentrate on one particular activity over the week.

The OE and Residential Experiences programmes were successful in enhancing self confidence, self esteem, and individual and group social skills and teamwork.

The disappointing aspect of the programmes at both schools was the fact that, to pay for these successful programmes, charities had to be established with many begging letters sent to a variety of philanthropic trusts and organisations yearly. Many of those organisations refused to consider our requests on the grounds that school activities should be paid for by the statutorily authority, a point of view I and many others can have no argument with.
