Proposed Schools (Residential Outdoor Education) (Scotland) Bill

Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

Unfortunately, putting this decision in the hand of LA's, in my experience, mean that there will be a conflict of interest where the LA themselves have the residential, outdoor provision. The provision may not be the most suitable for any given group of children but will be used to keep the money within LA. I believe a very simple grant application process for each school outlining number of children, number of staff and why the proposed centre is most appropriate is the most effective way forward to ensure we are best meeting the needs of our young people.
