# Proposed Schools (Residential Outdoor Education) (Scotland) Bill

#### Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

This is such an important experience for our young people, especially those from urban areas.

It could also be achieved through ring fenced money given to local authorities. However, I think legislation would be more effective - as the permanency of it would allow the outdoor education sector the guarantee of funding they need in order to build capacity. At the moment, there are too few outdoor education centres to be able to provide a week to every child.

Local authorities and schools already subsidise these trips to differing extents. There would therefore be some increase in costs to extend it to a universal entitlement. This will be met through general taxation. It should be said also that the provision of residential outdoor education will result in an economic boost to the rural communities involved in its delivery and will create jobs, contributing to economic growth. It is also likely to have a wider economic impact as young people become more aware of the tourism options available within Scotland. It will also have health benefits for the young people involved, which we know correlate to better economic outcomes. Therefore, while there will be financial costs, there will also be some positive economic impact of the plan.

Most schools also do a residential trip in P6/7, but 12-16 would work too. I think it would have most benefits in secondary if it was aimed at S1/2.

I think there needs to be discussion specifically with BAME families as to how provision of residential outdoor education can meet their needs. Anecdotally, at both my school and my children's school (both in Glasgow southside), there is a clear difference in attendance at residential trips between ethnicities, with BAME pupils far less likely to attend. Research needs to be conducted into why this is, and efforts made to remove any barriers.

It must be fully funded with no parental contribution required. Any form of contribution, regardless of whether it is means tested, will result in children missing out.
