

# Proposed Schools (Residential Outdoor Education) (Scotland) Bill

## Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

Engaging in OL can be more challenging for pupils with additional support needs. This could be to do with physical (visible and invisible) difficulties; but also cognitive/behavioural challenges for young people diagnosed with ADD; SEBD or ADHD.

Whether this proposal becomes law or not, there should be a strong focus on supplying guidance and awareness training for supporting the inclusion of pupils with additional support needs in outdoor learning activities. This includes what specific resources are required for these pupils to actively participate in activities.

Furthermore, the burden of providing such resources will be greater for schools with a higher number of ASN pupils. Parent volunteers could be sought where required. Or additional bursary for providing dedicated/trained staff.

Pupils associated with a religion should be allowed to keep religious clothing on should they wish.

Pupils with gender changes should be consulted about personal space and comfort in public areas such as toilets or dormitories. Allowances made for safety of these pupils where required.
