### Proposed Schools (Residential Outdoor Education) (Scotland) Bill

#### Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

#### Please explain the reasons for your response.

I had an opportunity to experience 2 weeks of hill walking, camping, canoeing and sailing. I probably would not have chosen to try these things on my own and it was a good learning experience for us all. We were no longer channelled into which marks we got but were able to progress and learn new skills and confidence. I still go hillwalking and enjoy sailing in the summer months. My son struggled attending school and he loved the opportunity to be in an outdoor setting and within nature. He felt comfortable and thrived there - he was able to join in with the challenges of the day and had a better time with this peers. Some of my son's friends have been through the care system and have never been out into the countryside - never seen a cow or horse in a field or stood near one. For some young people, they only know the life they currently live and sometimes that is not a good life for them depending on the family circumstances. They cope but they are not able to envision a different life for themselves in the future. Outdoor Residential Education gives them an opportunity to be away from their current circumstances but also to challenge themselves, build confidence, resilience and team working. These are important skills for all young people but more so for those from disadvantaged backgrounds.

Q2. Do you think legislation is required, or are there other ways in which the proposed Bill's aims could be achieved more effectively? Please explain the reasons for your response.

I do. I think it is important that it should include that schools are provided with an adequate budget to ensure that all young people have the opportunity.

Some families really struggle financially for their children to attend independent schools or receive bursaries for a variety of reasons. I think an opportunity for outdoor residential experience is a great leveller as well as providing an opportunity for young people to mix with those from different backgrounds.

I believe that it should be funded in full by the Scottish Government. I worry that if budgets were tight with local authorities that it would become less of a priority to provide a fully rounded experience and that the intention and experience would be diluted by funding issues. I think if you ask parents/carers to help with costs, then you may marginalise those who would benefit most. There are some parents/carers who do not apply for financial support for school meals etc as the process is so complicated and others may earn just above the qualifying criteria but are still struggling financially. Obviously it would be great if businesses could help with funding or meeting some of the costs but that should be a bonus rather than a goal for funding.

Obviously something like this has to have funding but there are times when you have to consider the impact and the benefits before the costs. This would mean that the government may have to make decisions elsewhere in their budgets to prioritise this. For providers of residential outdoor education, there would be benefits for them not only an increase in income but a more stable income source. This would filter through to their local community in terms of staff for catering, cleaning, maintenance etc.

Logically, there has to be a quality framework for the provision of outdoor centres. Obviously HMIE are the best placed to assess and set standards for the activities and the standards of welfare of the young people in their care. I think it should be statutory and part of the Bill.

I think it is a better age 12 - 16 as they are considered more mature and responsible as they have made the transition from primary to high school.

However, there may be occasions when a slightly younger age 10 - 11 would benefit - particularly those who may be having difficulty within the school or home environment. It may be that an opportunity to do something different could be a turning point for them.

I think schools are already pretty good at dealing with many of the above but if it goes forward; it might be helpful for some young people to have some input in how to make it better for all.

The only way to do this fairly is for the Scottish Government to allocate an amount to cover the costs for each individual young person. This could be allocated to the schools once a programme has been decided and agreed with any of the approved Residential Outdoor Education providers.
