

Proposed Schools (Residential Outdoor Education) (Scotland) Bill

Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

Q1. Which of the following best expresses your view of the proposed Bill? (Please note that this question is compulsory.)

Fully supportive

Please explain the reasons for your response.

The proposal sets out quite powerfully both the benefits of outdoor learning and the significant declines in opportunities in Scotland. Outdoor learning providers in all their forms are important employers in often rural locations. The proposal would, in addition to the very well expressed benefits for young people, be supportive of an important sector of the economy.

Q2. Do you think legislation is required, or are there other ways in which the proposed Bill's aims could be achieved more effectively? Please explain the reasons for your response.

Legislation is required to safeguard funding and to ensure long term sustainability. A similar guarantee of a residential experience for primary school pupils in Birmingham, England proved to be of tremendous value to the children of Birmingham, from some of the most deprived wards in Western Europe, but the lack of legislative force meant a Local Authority policy was vulnerable to the back and fore of local politics.

Q3. The proposed Bill will cover residential outdoor education provision for local authority and grant-aided schools only. Which of the following best expresses your view that independent schools or any other education establishments should not be covered by this obligation.

Targeted support such as that in the proposal is a realistic and somewhat reduces costs. If affordable it would be better to extend to all, but if a line has to be drawn, this is a generous and realistic place to draw it.

This provides the security of funding necessary and would better protect from the outcomes of the Birmingham Primary Guarantee noted above.

a significant reduction in costs

Scottish Outdoor Education Centre's independent Social Return on Investment study gave a ratio of 11:1. Or should that be -11:1? £11 was saved elsewhere for every £1 spent in residential experiences for young people.

Standard/ Quality of provision

Use of HMIE and AALA licensing will only partially cover the necessary elements of health and safety compliance and the educational quality / safeguarding. Additional assurance, covering elements not covered by HMIE or by AALA would be provided by utilising LOTC QB and Adventure Mark. These would cover the management of non-licensable adventure activity, and compliance of buildings, food safety, vehicles and other areas not covered by the proposal.

Equalities

This proposal would have a positive impact of children and young people with protected characteristics. The learning away research referenced in the proposal found more powerful benefits for children and young people in some of these groups.

Q10. How might equity of provision for all be ensured, regardless of socio-economic status? Please give reasons for your response.

The scheme itself does this, but there should be quality assurance of providers to ensure provision of equipment means no families are expected to buy equipment before a residential. There should also be recognition of young people who work and contribute to family incomes.

Sustainability
