

# Proposed Schools (Residential Outdoor Education) (Scotland) Bill

## Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

It has taken far too long for Outdoor Residential Education to obtain the recognition it deserves. By making it a statutory obligation of local authority education departments to provide this valuable experience is in my view the best way forward. It must be a legal right of every child to have this valuable educational experience.

Regardless of social background it should be an entitlement for young people to obtain this experience. The most important issue will be accommodating everyone I suspect at this time because of the number of closures. However this is likely to be a temporary problem until Local Authorities realise that it is more financially viable if they have their own centres. Most independent schools have their own well run outdoor education programs. They have certainly not suffered the same loss of provision that the state schools have experienced. It would only be a financial call on Scottish Government should they feel that they should be excluded from the spirit of the bill and I'm not certain that represents consistency of policy for the good of the young people in the country.
