

# Proposed Schools (Residential Outdoor Education) (Scotland) Bill

## Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

some increase in costs

I think there would be some increase in costs. Parents/carers quite often pay for these sort of things anyway, but it would be a lot of pressure on the families who are above the threshold for free schools meals but don't have enough spare income to pay for a trip. If the local authority is paying, I think it is again, unnecessary pressure on them to cut costs in other places. If the cost is somehow passed into schools, the same applies. The only good thing I can think of, financially, is the benefit to outdoor education centres and their staff.
