# Proposed Schools (Residential Outdoor Education) (Scotland) Bill

# Introduction

A proposal for a Bill to ensure that young people have the opportunity to experience residential outdoor education.

The consultation runs from 29 April 2022 to 22 July 2022

In the past in my local authority before the centre closed, the outdoor residential has always been provided to pupils in primary 7 as part of their transition to secondary school. Pupils were also given the opportunity to attend a private sector outdoor residential in S3, but this was also cut due to budget cuts by the local authority.

I think 12 to 16 is appropriate as the benefits that pupils can gain from an outdoor residential experience can give them good foundations to build upon in secondary school and their future endeavours.
